

Dear Client/Supplier,

Re: Information notice pursuant to article 13 of Italian legislative decree no. 196 of 30 June 2003 ("Personal data protection code")

We wish to advise that, relative to the establishment and performance of current contractual relationships with you, our company holds data relative to you, including that acquired verbally, directly, and via third parties, that is classed as "personal" under Italian legislative decree no. 196/2003, which provides for the protection of natural and legal persons in connection with the processing of personal data.

Under this decree, the data subject must receive adequate information on certain elements concerning the processing of the data that relates to them. In general, data will be processed in compliance with the principles of legality, propriety, relevance, completeness, and reasonableness in the interests of protecting your privacy and rights.

Therefore, in compliance with article 13 of legislative decree no. 196/2003, we are providing you with the following information.

1. The data provided by you will be processed in connection with the requirements arising from carrying out the contract, resulting legal and taxation obligations, and to allow the efficient conduct of financial and commercial relationships.
2. Your data will be processed throughout the currency of the contractual relationship as well as subsequently so as to comply with the law and to fulfill relevant administrative and accounting purposes.
3. The data may be processed in hard copy format, by computer, or through the use of tools and procedures that are appropriate to ensure the security and privacy of the personal data. In all cases, the processing of the data will be performed using principles strictly linked to the purposes indicated under point 1) through the use of appropriate measures to prevent alteration, cancellation, destruction, unauthorized access, and treatment that is prohibited or not in conformity with the reasons for which the data was collected.
4. The supplying of data is compulsory for all purposes relating to the fulfillment of the obligations provided for under the contract and law, by community regulations, and regulations established by authorities legally entitled to do so and by surveillance and control authorities. Should you fail to supply the data, it will be impossible to establish or properly conduct the relationship to the extent to which the data is required for carrying out same. Failure to provide all of the data that is not legally or contractually required will be assessed on a case by case basis by the company, which will make a

decision on the basis of the importance of the requested data relative to the conduct of the business relationship.

5. Your data (I.e.: company name, telephone number, mail address, e-mail address) might be disclosed by making the same available on our company's website.
6. Your data will not be communicated by us, the term "communication" being defined as "disclosing personal data to one or more entities identified other than the data subject, the data controller's representative in the State's territory, the data processor and persons in charge of the processing in any form whatsoever, including by making available or interrogating such data:"
 - to entities that can access the data under law, regulations, or Community legislation, within the limits of such provisions;
 - to entities that need to access your data for purposes supplementary to the relationship between you and us, within the limits of what is strictly necessary to perform such supplementary tasks;
 - to external professionals and consultants carrying out specific assignments on our behalf;
 - to banks for the management of payments and receipts arising from the performance of contracts.
7. We wish to advise that you may exercise at any moment your rights as provided for under article 7 of legislative decree no. 196/2003.
